Exaggerations and Extremes in Dog Conformation/Education and Communication

Context for the theme:

Because of the prominence of these issues in the media and among our stakeholders as well as significant welfare effects we are once more focusing on Brachys and especially the Brachycephalic Airway Obstructive Syndrome (BOAS). Despite the magnitude of attention, the awareness across several stakeholder groups, and many actions taken – we have seemingly failed, so far, to noticeably impact the health status in many brachycephalic breeds. There has certainly been a failure to impact the public perception of and desire for healthy dogs/brachycephalics.

We are still seeing extreme dogs on the street, in veterinary facilities and in show rings. In spite of increased activities, position statements, etc. from various stakeholder groups, there remains a lack of engagement/ resistance from others. With incomplete knowledge, it remains a challenge to know the source of all these dogs and to make a change in how breeding stock is selected in these breeds. Selection for and prevalence of healthy brachycephalic dogs continues to be a prime welfare issue to handle.

Key activities for this theme include identifying:

- why progress has been limited? Have we built in outcomes monitoring so that we will know IF we are having desired effect?
- gaps in effective efforts at education and communication to and between stakeholders
- priorities for actions to be taken, e.g.:
 - to prevent the media and marketing from promoting exaggerated features
 - to change the public perception of a “nice/desirable dog”
 - to have buyers of puppies not to choose the extreme
 - to influence the breeders not to choose the extreme for breeding
 - to involve breed clubs in a change towards less exaggerated breeding stock

- to increase the show judges' awareness, not only of their responsibility re dogs shown to them but the entire population by rewarding less exaggerated individuals at dog shows
- to have judges follow recommendations of breed clubs, kennel clubs and the standards to not award extreme dogs
- to have FCI, AKC and the KC to make necessary changes in breed standards that might be misinterpreted and, especially, how to make sure that judges interpret the breed standards
- to further involve the veterinary profession in collaborative efforts
- to gather epidemiological data
- focus on communication between stakeholders... identify opportunities for collaboration, or at least parallel actions.
- to promote research efforts that support practical change
